YOU MUST AGREE BEFORE YOU PROVIDE US WITH ANY INFORMATION

This **AGREEMENT** is made on this **29**th day of **November**, **2021** (hereinafter the "Effective Date") by and between **Fibonnacci 1123**, **PMA**, a Private Membership Association (hereinafter, "Fibonnacci 1123"), and Alive & Well, (hereinafter, the "Member") for the sole and limited purpose of retaining **Fibonnacci 1123** to provide International Registered Agent Services (defined below) to Member; and

For good and valuable consideration, Fibonnacci 1123 and Member agree as follows:

- Appointment: Subject to the terms of this Agreement, Member hereby retains Fibonnacci 1123 to provide International Registered Agent Services to Member and Fibonnacci 1123 hereby agrees to provide International Registered Agent Services to Member; and
- 2. **Services**: The services to be provided by Fibonnacci 1123 to Member (the "*International Registered Agent Services*") will be subject to the terms of this Agreement and strictly limited to:
  - a) providing a physical location within the Survey of the General Post Office for the Government of The United States of America; to serve as Member's **International Registered Office** (hereinafter "Registered Office"); and
  - b) serving as Member's **International Registered Agent** (hereinafter "*Registered Agent*") within The United States of America to accept Service of Process, notice or demand upon Member required or permitted by the laws of The United States of America; and
  - c) opening envelopes or other packaging for the items received by Fibonnacci 1123 at the Registered Office in its capacity as Registered Agent for Member, and forwarding such items to Member in the limited manner described in **Section 3** entitled "**Forwarding Requirements**":
    - Fibonnacci 1123 <u>WILL NOT FORWARD</u> (and will have no obligation to Forward) solicitations, product offerings, credit card applications, and junk mail to Member; and
    - ii. Member hereby instructs Fibonnacci 1123 to discard all solicitations, product offerings, credit card applications, and junk mail received by Fibonnacci 1123 in its capacity as Registered Agent for Member; and
- 3. **Forwarding Requirements**: Subject to limitations stated in Section 2(c), Fibonnacci 1123 will forward to Member the items received by Fibonnacci 1123 at the Registered Office in its capacity as Registered Agent for Member:



- a) Fibonnacci 1123 will do so by scanning the item into an electronic PDF file and forwarding the PDF file by email to Member at Member's last known email address, as such address is reflected on the books and records of Fibonnacci 1123; and
- b) An item will be deemed to have been timely forwarded to Member if the email is sent within two (2) business days after Fibonnacci 1123's receipt of the item; and
- c) Member has elected to use an email forwarding method; accordingly, Member agrees and understands that Fibonnacci 1123 will have no obligation to physically send an item to Member by mail or otherwise; and
- d) Notwithstanding Member's election to receive items by email, in lieu of forwarding an item by email, Fibonnacci 1123 shall have the option (but not the obligation) to forward an item to Member via the General Post Office for the Government of The United States of America to Member's last known mailing address as such address reflected on the books and records of Fibonnacci 1123. THIS OPTION MAY BE EXERCISED BY Fibonnacci 1123 IN ITS SOLE DISCRETION WITHOUT ANY NOTICE; and
- 4. **Member's Email and Mailing Addresses**: Member's current email and mailing addresses are set forth under Member's signature on the signature page hereof; and
  - a) Member hereby instructs Fibonnacci 1123 to forward any process, notice, demand or items covered by this Agreement to the email address; and
  - b) If Fibonnacci 1123 exercises its option to forward an item by mail, Member hereby instructs Fibonnacci 1123 to forward the item to the mailing address; and
  - c) Member must provide Fibonnacci 1123 with Notice of any changes in Member's email and/or mailing addresses; and
  - d) Fibonnacci 1123 will have three (3) business days after its receipt of such Notice to update its records; and
  - e) Member warrants that the email and mailing addresses provided by it to Fibonnacci 1123 are accurate, and bears the risk of any inaccurate email or mailing address provided by it to Fibonnacci 1123; and
  - f) If Fibonnacci 1123 receives two (2) returned or rejected items, either from the email address or mailing address, without any forwarding address information for Member, Fibonnacci 1123 may immediately and unilaterally terminate this Agreement and withdraw as Registered Agent for Member; and
  - g) Upon such termination, Fibonnacci 1123 shall have no continuing obligation to Member; nor will Fibonnacci 1123 owe Member any refund of fees; and
- 5. Permission to Sign, Open Mail and Packages, and Email Items:

Member hereby consents and grants permission to Fibonnacci 1123 to:

- a) sign for receipt on behalf of Member those documents served to Fibonnacci 1123 that require signature; and
- b) open the envelopes or other packaging for the items received by Fibonnacci 1123 in its capacity as Registered Agent for Member (including all service of process, notices or demands), and
- c) electronically scan and forward the same by email or by mail as provided in this Agreement; and
- Email deliveries will be sent by Fibonnacci 1123 to the email address provided by Member; and
- e) Member is solely responsible for maintaining the security and privacy of its computers and the email address, and bears all risks arising from access by individuals to Member's computers and/or email; and
- 6. **Membership Fees and Costs**: Member agrees to pay Fibonnacci 1123 a membership fee to join the International Registered Agent Services Membership Level; and



- a) Fibonnacci 1123's membership fee for the first year of the term of this Agreement is one hundred twenty (120.00 USD); and
- b) Thereafter, Fibonnacci 1123's membership fee is subject to change by Fibonnacci 1123 by Notice to Member given at least ninety (90) days prior to expiration of the then current annual term; and
- c) All membership fees payable to Fibonnacci 1123 under this Agreement are due on the date this Agreement is signed by Member for the first year of the term, and within thirty (30) days of invoice date for subsequent years; and
- d) If Fibonnacci 1123 does not receive payment from Member within such thirty (30) day period, Fibonnacci 1123 may unilaterally terminate this Agreement and withdraw as Registered Agent for Member, and Fibonnacci 1123 shall have no continuing obligation to Member; and
- e) In the event that Fibonnacci 1123 elects to forward items by mail to Member, the costs of the initial five (5) mailings during a calendar year will be **borne by Fibonnacci 1123**; and
- f) The costs of additional mailings during a calendar year will be borne by Member and will be due and payable by Member to Fibonnacci 1123 within thirty (30) days of invoice date; and
- 7. **Term:** The term of this Agreement will commence on the Effective Date of this Agreement and will continue from year to year unless terminated by either party in accordance with its terms; and
  - a) Either party may terminate the automatic renewal of the term of this Agreement by providing the other party Notice of non-renewal at least ninety (90) days prior to the commencement of the next renewal term; and
- 8. **Termination:** Fibonnacci 1123 shall have right to terminate this Agreement as provided in Section 4 (for returned or rejected emails and mail) and Section 6 (for failure to pay fees) without any rights of Member to cure; and
  - a) In addition, either party may terminate this Agreement upon thirty (30) days' prior Notice to the other party if the other party is in default under this Agreement and does not cure the default within such thirty (30) day notice period; and
  - b) If Fibonnacci 1123 exercises its right of termination as a result of Member's default, Member will not be entitled to any refund of fees; and
  - c) Either party may terminate this Agreement at any time without cause upon ninety (90) days prior Notice to the other party; and
  - d) If Fibonnacci 1123 exercises its right of termination without cause, Fibonnacci 1123 will provide Member a pro rata refund of the fee paid by Member for the then current annual term; and
  - e) A termination by Member without cause will not entitle Member to any refund from Fibonnacci 1123; and
  - f) Upon any termination of this Agreement in accordance with this Agreement, Fibonnacci 1123's obligation to provide Member any International Registered Agent Service will terminate automatically and without any further notice or other action; and
- 9. **Record Retention:** Fibonnacci 1123 is not obligated to maintain originals or copies of any item received by Fibonnacci 1123 as Member's Registered Agent; and
- 10. **Change of Registered Office**: The current address of the Registered Office is set forth under Fibonnacci 1123's signature on the signature page of this Agreement; and
  - a) Fibonnacci 1123 may change the location of the Registered Office at any time in its sole discretion; and
  - b) In such event, Fibonnacci 1123 will give Notice to Member of the change in location and will file, at Fibonnacci 1123's expense, all required notices within the office of the Secretary of State for the Government of The United States of America, to ensure Fibonnacci 1123's



continued maintenance of a Registered Office for Member during the term of this Agreement; and

- 11. **Indemnity:** Member shall defend, indemnify and holds harmless Fibonnacci 1123 and Fibonnacci 1123's representatives, agents and staff from any liability, judgment, claim or legal action that may arise as the result of or pertain to the performance of International Registered Agent Services, or from Member's failure to provide Fibonnacci 1123 current contact information for the forwarding of Service of Process, notice or demand; and
- 12. **Notices**: All notices required or permitted under Sections 4, 6, 7, 8, and 10 of this Agreement (collectively the "Notices") must be in writing and will be deemed to have been validly given upon receipt, if sent by commercial overnight delivery, or by the third business day following deposit in the mail, postage prepaid, and addressed to the party at the mailing address following its signature below; and
  - a) Each party may change such party's mailing address for Notice purposes by giving Notice in accordance with this section of the Agreement; and
  - b) Facsimile transmission and email are not valid methods of providing Notice under this Agreement; and
- 13. Governing Law; This Agreement is governed by the laws of The United States of America; and
  - a) The exclusive jurisdiction and venue for any action by any party arising out of or relating to this Agreement is in The United States of America courts; and
  - b) The parties consent to jurisdiction and venue, and waive all objections thereto, including objections based upon the convenience of the jurisdiction and venue; and
- 14. Relationship between the Parties: Member and Fibonnacci 1123 are independent contractors; and
  - a) Neither party is the agent, partner, joint venturer or employee of the other party; and
  - b) No third party fiduciary relationship exists between Fibonnacci 1123 and Member as a result of this Agreement or otherwise; and
  - c) Neither party has any right to bind or obligate the other party in any way; and
- 15. **Signatures**: This Agreement may be executed in counterparts and all counterparts shall be construed together and constitute one agreement; and
  - a) A signature provided by facsimile transmission or by online digital signature shall constitute a valid signature for the purpose of this Agreement; and
- 16. **Acknowledgements**: Member acknowledges and understands:
