I want it to be known that I no longer wish to be regarded as a member of the Roman Catholic Church. I do not consider myself part of the Roman Catholic Church. I also renounce citizenship with the Vatican City State, and any and all Oaths.

I am outraged and object to the on-going Luciferian practices of human sacrifice and pedophilia, and worldwide, human rights violations of the Roman Catholic Church; its Cardinals, Bishops, Priests and members.

I object to the fact that the Vatican City violates its pledge of perpetual neutrality in the Lateran Pacts of 1929, agreements made in 1929 between the Kingdom of Italy and the Holy See, where the Pope was pledged to perpetual neutrality in international relations and to abstention from mediation in a controversy unless specifically requested by all parties.
