Affidavit of Fact

Comes now Elisabeth Chalaca Odou, Trustee (hereinafter “affiant”) being competent to testify and being over the age of twenty-one years, sworn according to law to tell the truth to the facts related herein states that affiant has first hand knowledge and believe that these facts are true to the best of affiant’s knowledge and belief, and;

On the 57th Day in the Year of Yahweh 6024, translated the 15th day of May in the two thousand and twenty-second year of the new covenant in Yahushua’s name affiant hereby states,

1. Affiant states that Elisabeth Chalaca Odou, (hereinafter “ECO”) on the 14th day of February, 2022 signed and submitted a form known as Resident DECLARATION at 09:10 PM UTC-6 declaring EOC’s residency in the State of Florida, one of the original States of the Union of The United States of America, evidenced within Exhibit 1 of the Affidavit of Fact, and
2. On the nineteen day of February, 2022 affiant has withdrawn any and all moral, financial spiritual support from the Democratic and Republican Parties. Affiant has rebuked any and all national or international classifications created by the Democratic and Republican Parties. Affiant has withdrawn and or rescinded any and all registration with the Democratic and Republican Parties and therefore no longer carries the title of constituent or independent voter, unaffiliated voter or non-affiliated voter within the United States for or either the Democratic or Republican Parties. Affiant has claimed any vote back and shall exercise the voting rights within a real social compact through the North American National Party wherein Affiant has declared to be a member of within The United States of America. Evidenced within Exhibit 2 of this Affidavit of Fact, and
3. Affiant states that on May 14th, 2022 at around 1.30 PM UTC-6 found out that ELLIOT WELD (Respondent 1) reporter at the Key West Citizen published an article titled “**Fleming Street restaurant cited for operating without business license**”. Evidenced within Exhibit 3 of this Affidavit of Fact, and

4. Respondent 1 decided to publish an article **without Affiant's consent** and without researching what is true or false by taking the input of the political Sub-division employee of the CITY OF KEY JIM YOUNG (Respondent 2). This article has for goal to slander EGG O'CLOCK, PMA and Affiant's reputation based on lies such as "Cocotte O'Clock DBA Egg O'Clock, was operating without "any kind of license". **COCOTTE O'CLOCK, LLC never did business as EGG O'CLOCK**. Evidenced within Exhibit 4 of this Affidavit of Fact, and

5. Respondent 1 states in his report that "Code Director Jim Young, who is also not a member of the business, was able to later purchase soup at the restaurant without incident, and observed other customers doing the same".
EGG O'CLOCK, PMA operates under its Articles of Association and by-laws. **By ordering food JIM YOUNG (Respondent 2) became a member of EGG O'CLOCK, PMA which puts JIM YOUNG into a conflict of interest** by representing himself as a Member and also an employee of the political sub-division CITY OF KEY WEST.
Respondent 2, **JIMMY YOUNG, EGG O'CLOCK, PMA Member** violated the EGG O'CLOCK, PMA Articles of Association and by-laws by **publicly slandered** EGG O'CLOCK, PMA. Evidenced within Exhibit 5 of this Affidavit of Fact, and

6. Respondent 1 states further in his report that "Yates said Egg O'Clock was, according to evidence, operating as a restaurant, and was not under any category exempt from obtaining business permits. **EGG O'CLOCK, PMA is a Private Membership Association and not a restaurant**. Evidenced within Exhibit 6 of this Affidavit of Fact, and

7. Repondent 1 reports that "Assistant city attorney Rod Ramsingh (Respondent 3) informed Yates that Odou is claiming to be a "sovereign citizen" and "not subject to any jurisdiction." **Affiant rebukes the allegation calling Elisabeth Chalaca Odou, Trustee a "sovereign citizen"**.
"Sovereign citizen" is NOT in any case the Affiant's Status. The term "**sovereign citizen**" is a term used as a vehicle to **justify murder** and therefore to call someone a "**sovereign citizen**" is hereby **attempted murder** because each individual knows that an overwhelming force will be brought against those profiled with the term "**sovereign citizen**".

8. Respondent 1 reiterates the term "**sovereign citizen**" by reporting that "The sovereign citizen movement is a non-centralized movement of people claiming that the commonly-recognized government's laws are illegitimate and do not apply to them. According to the Southern Poverty Law Center, five such groups exist in Florida."

9. Affiant states it is a known fact that Southern Poverty Law Center has infiltrated law enforcement centers throughout the country. Southern Poverty Law Center uses training videos and slides to train agents to use extreme prejudice on anyone attempting to assert their rights, and tagging them with the term "**sovereign citizen**" to turn local and state police into political assassins. Most of the whistleblowers are simply attempting to expose a fraud being committed by the Bank of New York Mellon.

10. Affiant hereby states that the Southern Poverty Law Center, a radical left wing group of men who started their own cause when one of its founder's family members was shot by a 16 year old. The SPLC alleged the men were making claims of **"sovereign citizenship" which was found to be false at a later date.** SPLC was founded by a well-known terrorist that had bombed federal buildings in the 1960's. See attached "Statement of Probable Cause" Ramsey County attorney complaint number: 2144737-1 pages. 6 and 7 for the profile Mark Kempe builds. Here Mark Kempe falsely claims valid filings done in a procedurally correct manner are the profile of a **"sovereign citizen"** "and not a mere "whistleblower" attempting to gain justice.
11. Most if not all people profiled as a **"sovereign citizen" live in constant danger** because anytime the profiled individual comes in contact with any police officer **the encounter could turn into murder** on the part of the police officer against the profiled **"sovereign citizen"**.
12. Respondent 1 and Respondent 3 by statement reported on the Newspaper "Assistant city attorney Rod Ramsingh (Respondent 3) informed Yates that Odou is claiming to be a "sovereign citizen" and "not subject to any jurisdiction." **are clearly attempting murder** on the Affiant **by alleging a dangerous false statement that Elisabeth Chalaca Odou, Trustee could by any matter be involved in the Southern Poverty Law Center, a radical left wing group.**
13. Affiant states that Respondents were profiling and discriminating upon EGG O'CLOCK, PMA and Elisabeth Chalaca Odou, Trustee by **intentionally spreading lies and false accusations** against Affiant on the local Newspaper, violating Affiant's Federal Common Law Lien, forcing members of the EGG O'CLOCK, PMA into Internal Revenue Trust in one of the territories of the United States Virgin Islands, Puerto Rico, City of London, Vatican City and the District of Columbia from the metes and bounds and seaward boundaries of The United States of America to which Claimant has claimed Claimant's lot in accordance with the **Law of Nations, violating all Public Laws-101.**

Affiant alleges being a **declared resident and domiciled in the State of Florida, one of the original States of the Union of The United States of America** and the actions by Respondents to enforce corporate policies of the political sub-division of the CITY OF KEY WEST charter upon affiant by forcing affiant to contract with their courts are in violation with the **US Code title 28 rule 17 b. ". "The capacity of an individual, other than one acting in a representative capacity, to sue or be sued shall be determined by the law of the individual's domicile. The capacity of a corporation to sue or be sued shall be determined by the law under which it was organized"**.

Affiant alleges that Respondents are in violation with the EGG O'CLOCK, PMA Articles of Association by trying to deprave Affiant's right to peacefully assemble and associate.

Affiant alleges that **Respondents are attempting murder** on Affiant by trying to force association into the Southern Poverty Law Center, a radical left wing group and qualifying Affiant as a **"sovereign citizen"**.

Furthermore, Affiant alleges that Respondents are committing Communism for the refusal to acknowledge Affiant's right to personal property therefore depriving Affiant the right to life, liberty and property in accordance with **Article 8 of the Bilateral Social Compact** Agreement by and between the people for the States of the Union of The United States of America, and

COURSE OF REMEDY

Respondents have 10 days to retract, cease and desist the article, posted on the Key West Citizen Newspaper on May 14th, 2022. **To make public apologies to Affiant in the same font of the original article in the front page** of the Key West Citizen Newspaper.

Respondents have 10 days to **remove the allegation stating that Affiant could have any sort of association with the Southern Poverty Law Center, by qualifying Affiant as a "sovereign citizen"** putting Affiant's life in danger and committing an attempted murder on Affiant. If the course of remedy is not effective in 10 days it will be considered as a **nefarious act, a violation of all Public Laws101 and be brought to the WAR CRIME tribunal.**

Respondent 2, JIMMY YOUNG is revoked from EGG O'CLOCK, PMA membership for slander as of May 15th, 2022. Respondent 2 is not allowed to enter into EGG O'CLOCK, PMA by doing so he will be charged for trespassing.



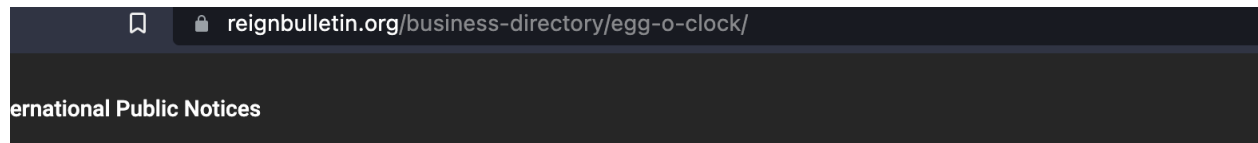
