LETTER OF NON-ABANDONMENT

I have been fighting a losing battle for the past 5 months. One that has everyone trying to prevent me from providing for my children. It is not my desire for my children to live without their mother. This situation was forced on me and my children.

Due to an extremely abusive relationship, I was leaving Vancouver, WA, the area I had been living in, so that I can live without fear. I managed to find a really good work opportunity that included housing. Andrey did not like the idea that I was leaving the area so he used the children as pawns as an attempt to keep me in the area. Andrey's only concern was that I didn't have sex with another man and that his status in the U.S was secured regardless of our marriage being over for some time.

It started with being served court orders preventing me from taking the children out of state. At the time (8/30/2021) the children and I were already without a residence in the state of Washington and was on route to our new home. Because of the court order the children and I were forced to stay in a friend's house in her bedroom thereby rendering the children and I homeless. That lasted over four months until I was asked to move out regardless of them knowing I had nowhere else to go. Couple weeks following, the pressure in the house increased, for example the mother of my friend asked Me and the kids to not drink their water. This is when I requested Andrey to take the kids in his care as I did not want them living in an environment where they are nervous to eat and drink and my options for housing in Vancouver were gone.

While staying at my friend's house Andrey offered to rent a place for the children and I but would withdraw the offer when I would bring it up. Another offer that was withdrawn by Andrey was to move the trailer we jointly owned to Emmanuel Baptist church's parking lot as a temporary housing solution. In addition to not helping move the trailer, he turned around and talked to the members of the church to prevent me from even staying at the church, though a non-member was staying in the parking lot, thereby making Me and the children homeless, a human rights violation. The action by the board was an act of prejudice against a woman and children in the act of making them homeless. These types of actions were on going where I would be offered something and then it would be withdrawn. I was under a constant state of not knowing if I would have housing for my kids.

Andrey Runov is a liar and drunk and interprets things like a drunk and only a former wife would know that better than anyone. All of his friends and family support Andrey because they believe his lies. As I look back at the whole marriage it is apparent that from the beginning, I was used to comfort his fear of being deported. I was used legally as an anchor baby carrier. Since the time I was being shown how deceitful Andrey is, he realized his immigration status may be affected and begin to latch on to the children as his anchor to stay in the country. When in fact prior to me trying to flee the abusive relationship, he showed no interest in the children. Andrey is only concerned with his own desires; I did not hand over custody of my children to anyone. Andrey uses opportunities to make himself look good in the eyes of the community as a way of getting what he wants. Andrey and all of his family stand with righteous indignation and snub their noses against anyone that is not Russian. They all use the Bible and its versus to condemn all other nationalities to hell on a daily basis. Help came when the non-Russian left the state and all of a sudden help arrived. The whole Russian family and friends conspired together to push the non-Russian woman out, out of any form of help and out of the state with the help of the court and Andrey's lawyer, that lies continually under oath in the court and the judge knows it otherwise the judge would be incompetent.

Andrey is claiming he loves his children yet refused to help support the children the past 5 months and he motions the court to make his children a ward of the state. Like I said, Andrey is a liar.

I, Jennifer Lyn Runov hereby declare that I have never abandoned Isabella Runov, Alina Runov nor Daniel Runov in anyway. As stated above, the whole Runov Family, the court and their lawyer conspired to force a mother away from her children so they could raise the children Russian and not American.
