Comes now the sole Trustee to JOSERVICE, PMA hereinafter “Affiant” being competent to testify and being over the age of twenty-one years, sworn according to law to tell the truth to the facts related herein states that Affiant has first-hand knowledge and believes that these facts are true to the best of Affiant’s knowledge and belief, and

SECTION I. PERSONS AKNOWLEDGED

1. Affiant states that on (March 19th, 2022) the living man Joel Bernard Lucien Odou hereinafter “JBLO” completed, signed, and submitted a form known as Resident Declaration at 09:55 PM UTC-6 declaring JBLO’s residency in State of Florida, one of the original States of the Union of The United States of America, evidenced in Exhibit 1, page 6 of this Affidavit, and
2. On (March 19th, 2022) JBLO signed and submitted the Bilateral Social Compact Agreement by and between the people for the States of the Union of The United States of America entering into the lawful jurisdiction and venue of the public Tribunals of and for The United States of America in accordance with Law of Nations evidenced in Exhibit 2, page 7 of this Affidavit, and
3. On (March 19th, 2022) Affiant signed a Political Affiliation Declaration as a member of the North American National Party for The United States of

America hereinafter “NANP” foreign to the corporate political parties for the United States corporation evidenced in Exhibit 3, page 8 of this Affidavit. On (March 26th, 2022) JOEL BERNARD LUCIEN ODOU, PMA proclaimed existence within the NANP published Three (3) consecutive days confirming the PMA as a member of a political party foreign to the corporate political parties for the United States corporation evidenced in Link 1, page 5 of this Affidavit, and

4. On (March 29th, 2022) minutes were entered as international Public Notice for Three (3) consecutive days within the Reign Bulletin Publication for the establishment of JOSERVICE, PMA hereinafter “Joservice” a private membership association providing a Natural Area Code hereinafter “NAC” further confirming the PMA within the metes and bounds and seaward boundaries of the States of the Union of The United States of America evidenced in Link 2, page 5 of this Affidavit, and
5. On (August 23rd, 2022) JBLO took an oath to the Nation of The United States of America affirming JBLO as an American National thereby becoming one of a permanent population of the States of the Union within the metes and bounds and seaward boundaries of The United States of America evidenced in Exhibit 4, pages 9 through 11 of this Affidavit, and

SECTION II. EVENTS

1. On (April 25th, 2022) Michael Herrera hereinafter “Client” agreed to and signed a members liability disclosure hereinafter “Contract” with Joservice for private construction services agreed to both by Affiant and Client evidenced in Exhibit 5, page 12 of this Affidavit, and
2. On (October 20th, 2022) Client requested Affiant provide private construction services, per the Contract, within Client’s hotel Coco Plum located at (611 Whitehead St. Key West, Florida 33040), and
3. At approximately 11 AM UTC-4 an employee of City of Key West code enforcement arrived and demanded Affiant stop working as no construction permit was delivered informing Affiant that two persons died a week prior, interpreted by Affiant as a scare tactic. Affiant complied and began to clean and put tools together. Affiant parked the work van on the property of Coco Plum to pick up Affiant tools, and
4. At approximately 11:30 AM UTC-4 at Coco Plum Two (2) other employees of City of Key West code enforcement arrived without identifying themselves and proceeded to photograph the outside and inside of the work van Affiant parked. Affiant asked who they were, what they were doing and told them that they were not allowed to photograph the inside on the work van, that the employees were trespassing upon private property, and
5. One of the employees of City of Key West code enforcement requested Affiant’s Driver’s License and Affiant informed both employees that they had no right to ask for a Driver’s License. The employee requesting the Driver’s License affirmed that he can request and upon refusal to comply he would call foreign corporate municipal agents for City of Key West. Affiant refused to show them Affiant’s Driver’s License and foreign corporate municipal agents were called, and
6. 11) At approximately 11:40 AM UTC-5 a foreign corporate municipal agent for City of Key West hereinafter “Agent” arrived to speak with Affiant initiating

an investigation. Agent began by explaining why Agent was present, why the employee of City of Key West code enforcement had the right to photograph the inside of Affiant's van, and that employees of City of Key West code enforcement had authority to request any identification. Agent then requested Affiant's Driver's License. After hesitation Affiant provided Affiant's Drivers License issued by NANP and Agent insisted on taking said License, and

7. Agent attempted to convince Affiant that Affiant's Driver's License was not valid in the corporate State of Florida and that Affiant needed a United States Postal Service hereinafter "USPS" address. After a few minutes of argument regarding Affiant's NAC Agent decided to scan the QR code on Affiant's Driver's License then informed Affiant that the NAC was not a physical address stating it was just a bunch of numbers. Affiant attempted to explain to Agent that the NAC is an actual address but Agent was unable to understand. Agent asked one of the employees of City of Key West code enforcement to scan Affiant's license plate so Agent could determine if the van was registered to Affiant and provide information Agent was requesting evidenced in Links 3 and 4, page 5 of this Affidavit, and
8. The employee of City of Key West code enforcement scanned the van's license plate to obtain a USPS address for sending a summon to the USPS address they attached to Affiant by scanning said license plate evidenced in Link 5, page 5 of this Affidavit, and
9. After Agent left the scene one of the employees of City of Key West code enforcement stayed parked behind van and returned to speak with Affiant to 'help Affiant' with the situation but Affiant was on the phone. The employee seemed disturbed over Affiant's lack of acknowledgment and left, and
10. On (October 21st, 2022) Client went to the city hall of City of Key West, wrote, and signed an affidavit regarding Joel Odou Exhibit 6, page 13 of this Affidavit. Said affidavit was a violation of the Contract signed by Client resulting in a Membership Revocation between Client and Joservice evidenced in Exhibit 7, page 14 of this Affidavit, and
11. Since this recorded event Joservice has been certified with the General Post Union of The United States of America acknowledged the 216th Day in the Year of Yahweh 6024 evidenced in Exhibit 8, page 15 of this Affidavit, and

SECTION III. AVERMENT

1. Affiant hereby objects to JOEL BERNARD LUCIEN ODOU, PMA hereinafter "ODOU" being attached to a USPS address by any one person operating as an employee of City of Key West, any agent for said City or the foreign political subdivision thereof, or any person operating for the corporate State of Florida for the purpose of associating with and/or contracting with ODOU. Said purpose is acknowledged as trespassing upon ODOU as a member of NANP and ODOU hereby notices all entities of City of Key West that any further action shall be considered as violating the ODOU's civil and natural obligation and right not to be compelled to belong to an association, specifically FLORIDA BAR a private membership association through admission acknowledged as evidence that hearings conducted within the Municipalities and foreign political subdivisions of the corporate State of Florida are in fact private hearings and not hearings of a free and independent State of **these** United States. It is acknowledged that

said members are subjects to the Crown of Great Britain (Lord Mayor of City of London Corporation) evidenced in Links 6, 7, and 8, page 5 of this Affidavit, and

2. Affiant hereby objects to Agent's claim that a NAC is not an actual address. Said system is utilized to identify specific areas anywhere on earth evidenced in Link 9, page 5 of this Affidavit. The general post office of The United States of America utilizes said NAC to identify and acknowledge Declared residents and American Nationals as within the metes and bounds and seaward boundaries of The United States of America. Failure to recognize this specific identifying code may constitute arbitrarily placing one person within another foreign international institution's address system thereby trafficking one's person arbitrarily into another jurisdiction and venue outside of the jurisdiction and venue of The United States of America, and

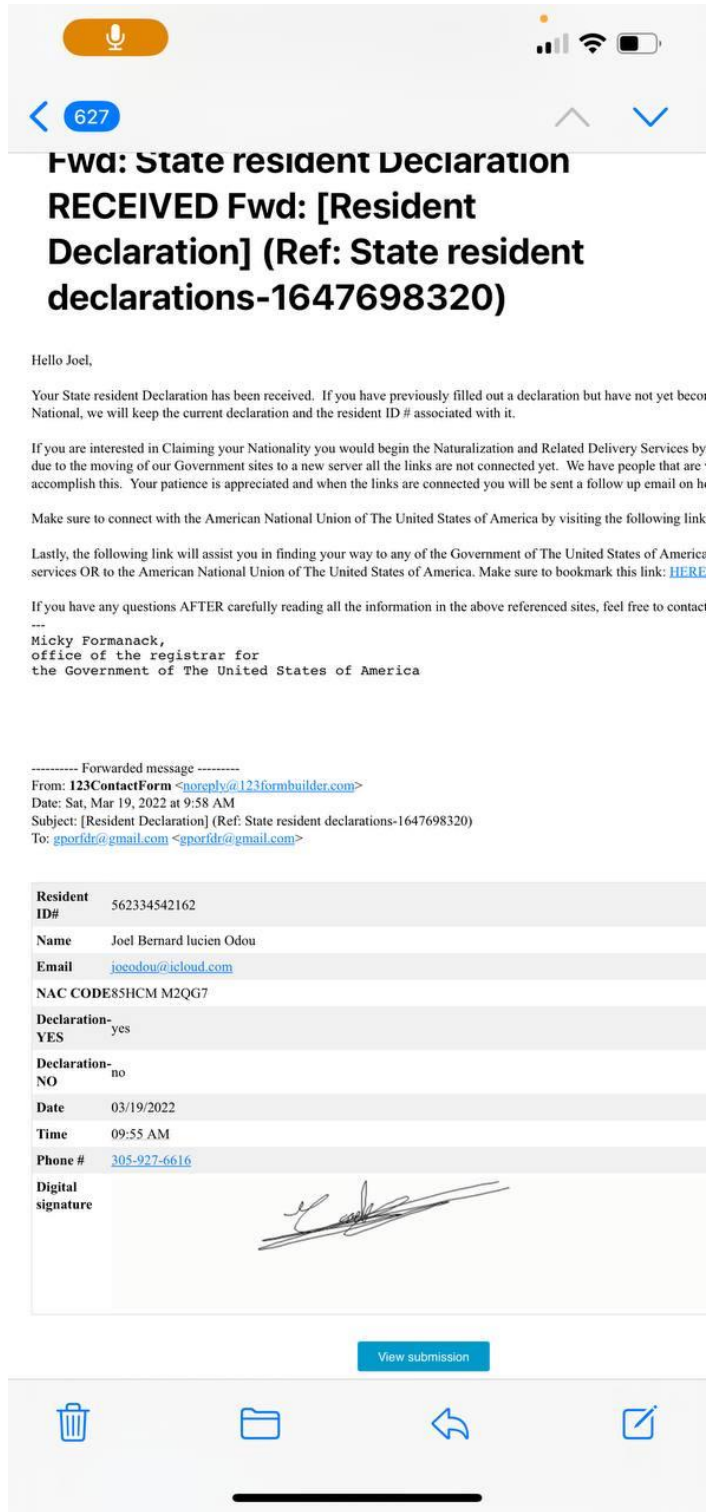

I, Joel Bernard Lucien Odou, hereunto Subscribed, Do solemnly and sincerely Declare and affirm, that The United States of America is and of right ought to be a free Sovereign and Independent Nation—and I do forever renounce all Allegiance, Subjection and Obedience to the Three-City Empire which consists of the City of Washington D.C., City of London, and Vatican City, and I do further solemnly, sincerely and truly declare and affirm that I never have since the declaration of Independence, directly or Indirectly aided, assisted, abetted or in any wise countenanced the Three-City Empire consisting of the City of Washington D.C., City of London, and Vatican City, its Generals, fleets or armies; Allegiance or their adherents in their claims upon these United States, and that I have ever since the declaration of the Independence thereof demeaned myself as a faith full citizen, subject or resident of this or some one of the United States, and that I will at all times maintain and support the freedom, sovereignty and Independence thereof, on my honor, and

Further, I Joel Bernard Lucien Odou, will also abide by the original organic laws for The United States of America, and

Further, I, Joel Bernard Lucien Odou, hereby accept and acknowledge that my particular Nationality carries with it separate and equal station with Nationals in “one of the United States” within the original Union, so that my Nationality shall have standing among all other Nations and States in The United States of America or otherwise, and

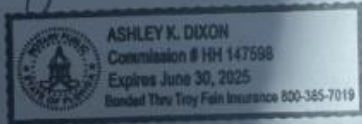
