## NOTICE OF WITHDRAWAL OF REPRESENTATION

IN THE MATTER OF HOWARD FREDERICK WALKER III, PMA holding the office of Governor and president for the Government of The United States of America:

The trustee of **KEITH EDWARD LIVINGWAY**, **PMA** (hereinafter "Trustee A") feels that the trustee of HOWARD FREDERICK WALKER III, PMA (hereinafter "Trustee B" or variation thereof) does not have the best interest of Trustee A in any form of international representation of Trustee A, and

Further, under Articles 21 paragraph 1 of the Universal Declaration of Human Rights it reads:

1: Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.

Trustee A hereby chooses the direct alternative to take part in the Government of its country meaning the office of the Governor and president for the Government of The United States of America itself and not Trustee B as a representative of Trustee A to the office of the Governor and president for the Government of The United States of America, and

As a member of the North American National Party, Trustee A hereby withdraws the following political rights:

1: Trustee A's vote is hereby withdrawn from Trustee B, and

2: Trustee A's full political power is hereby withdrawn from Trustee B, and

3: Trustee A's full representation to the office of the Governor and president for the Government of The United States of America is hereby withdrawn, and

4: Trustee A's full political support is hereby withdrawn from Trustee B, and

Any and all other political, civil, executive and judicial power is hereby withdrawn from Trustee B and is further hereby reserved until the next election cycle of the North American National Party wherein Trustee A is a member in good standing, and

## **INTENTIONS:**

IT IS THE INTENTION of Trustee A to protect the interests of KEITH EDWARD LIVINGWAY, PMA, politically or otherwise, and

Summary:

This action is taken to protect the family of Trustee A due to experiencing personal hostility being used against Trustee A by Trustee B, and

Politically, when votes are offered and accepted and international representation is granted, it is not honorable to use that grant of political power against those grantors as has happened in this case, and

Trustee A is in honor to remove said political power and other basic human rights and reserve them until the next election cycle and does not relieve Trustee A of any other liability that Trustee A may have or has been accepted as it pertains to the Government of The United States of America, and

This is a voluntary political decision made by Trustee A and hereby objects to any negative political assertions stated against Trustee A by Trustee B in the past, present or future , and

IT IS HEREBY WITHDRAWN, on the one hundred and seventy eighth day in the year six thousand and twenty-four, translation the thirteenth day of September, 2022, and
